Sub: Permission to open TDC Honours course in English & Economics from the session 2020-21.

**DECISION OF THE EXECUTIVE COUNCIL :**

RESOLVED that the College be granted permission to open TDC Honours course in Economics from the session 2020-21 with following conditions:

1. There is immediate need to include books recommended in the reading list of the newly implemented CBCS programme.
2. There should be a separate classroom for taking major classes. The present set up has a big classroom/ hall partition in to smaller classrooms which is totally undesirable.

However the permission to open major course in English is not recommended by the inspectors for the following reasons:

1. Library is inadequate and there is no electronic subscription of journals.
2. The status of the HOD is undetermined.

The Affiliation Committee observed that the college has three faculty members in the department of English which qualifies for opening major in English as per G.U. ordinance. The college may be permitted to open major course in English with the conditions of adding more books relevant to the English major course.
